## **Low Income Energy Assistance Program** (LIEAP) Application Period Opens Jan. 3

Rolling Hills Electric receives requests for assistance with member electricity bills throughout the year. The Low Income Energy Assistance Program (LIEAP) is a federally funded program that helps eligible households pay a portion of their home energy costs by providing a one-time per year benefit.

The 2023 LIEAP application period is from TUESDAY, JAN.

3, 2023, THROUGH THURSDAY, MARCH 30, 2023, BY 5 P.M. To qualify, applicants must meet the following requirements:

- ▶ An adult living at the address must be personally responsible for paying the heating costs incurred at the current residence, payable either to the landlord or the fuel vendor.
- Applicants must demonstrate a recent history of payments toward purchases of the primary heating energy.

The combined gross income (before deductions) of all persons living at the address may not exceed 150% of the federal poverty level.

The benefit levels vary according to the following factors:

- ► Household income
- ▶ Number of persons living at the address

For more information and/or to apply online, visit www.dcf.ks.gov, select the **SERVICES** tab at the top. then scroll down and click on **ENERGY ASSISTANCE (LIEAP).** Applications must be received at the DCF office PRIOR TO 5 P.M., MARCH 30, 2023. Late arrivals will not be considered for assistance. The state will contact Rolling Hills Electric to verify payments are being made on the account and the account is active in the applicant's name. LIEAP payments will come directly to Rolling Hills Electric and be applied directly to the account.

## **Are Space Heaters Making** Your Bill Higher?

"Why is my electric bill so high? I have one of those energy efficient space heaters. There must be something wrong with my meter! Can someone come check the meter? Something has to be wrong!"

In the electric business, we hear the above scenario quite often during the colder months. Some members resort to using electric space heaters throughout their home to save on propane or to warm a specific area of the home. Lets break this down a bit to show how these "energy efficient" electric space heaters take a big bite out of your checkbook.

If you have a 1,500 watt space heater, regardless of brand name or efficiency rating, it will use 1.5 kWh per hour. Let's say that in January, you run this heater for only eight hours daily Monday-Friday and 16 hours daily on Saturday and Sundays.

9 days at 16 hours per day = 144 hrs x 1.5 kWh = 216 kWh 22 days at 8 hours per day = 176 hrs x 1.5 kWh = 264 kWh 216 kWh + 264 kWh = 480 kWh used 480 kWh x 12.7¢ per kWh = \$61.12 (plus tax, franchise fee where applicable, power cost adjustment (PCA), etc)

If more than one space heater is used for the same hours, take the above calculation and multiply it by the number of heaters in use. If you use a space heater to keep pipes from freezing constantly for the month of January:

24 hours per day x 31 = 744 hours x 1.5 kWh = 1,116 kWh x 12.7¢ = \$142.11 (plus tax, franchise fee where applicable, power cost adjustment (PCA), etc)



These examples are based on the single phase winter rate and in addition to your regular household usage. Knowing this information before you use supplemental heating can help alleviate the "ouch!" in upcoming heating bills.
