Martin stressed to the students what they should and shouldn't do if they are in an accident involving a

power line and explained that by calling 911 to report a power line is involved they will dispatch the electric company immediately so no time is wasted in getting help. One student made a great point when talking about accidents involving power lines by saying, "Electric companies are like an unspoken first responder!"

WHAT TO LOOK FOR AFTER A STORM

When the skies clear and the birds sing, know that the storm's fury could have created electrical hazards that you may or may not be able to see. Conditions in which stray electricity could energize the area, a person or objects include:

#### DOWNED POWER LINES

- on the ground
- under storm debris
- draped over or touching a
- metal fence
- covered by standing water across or by the road
- hidden in tree branches

#### THER POSSIBLE DAMAGE

- drooping or sagging lines (never try to move one)
- split or broken utility poles
- damage to a padmount transformer (green box)
- lightning strike to a substation transformer
- damaged or unstable guy wires

NEVER GO NEAR downed power lines or other damaged electrical equipment to assess damage or clean up the area. STAY AWAY and call 911 to report damage.

Power lines and other electrical equipment do not have to be sparking, arcing (giving off a flame) or on fire to be energized.

# 2020 Property Tax

Rolling Hills paid \$ \$1,362,569.01 in property taxes in 2020, a 3.5% increase over 2019. The chart below shows the amount paid to each county, as well as the percentage increase that pertains to each individual county.

The members of Rolling Hills Electric Cooperative, ultimately pay this bill. This is where part of the money goes when you pay your electric bill each month, as the cost of property taxes directly affects the cooperative's bottom line.
